

**Funds of Which's Protocol Processes are to be Launched
by the Ministry of Treasury and Finance Within the Scope of Tech-InvesTR-2018 Call**

As is known, "Tech-InvesTR Venture Capital Support Program" has been established in cooperation with TÜBİTAK and the Ministry of Treasury and Finance in order to encourage the funds to invest in early stage technology based companies that will provide added value to our country's economy and to improve the venture capital ecosystem. Within the scope of "Tech-InvesTR Venture Capital Support Program" TÜBİTAK has launched the "Tech-InvesTR 2018 Call" on 14.06.2018.

As a result of the assessment concluded by TÜBİTAK, 34 requests for participation in 10 separate funds of 23 university institutions composed of 13 Technology Development Areas, 9 Technology Transfer Offices and 1 Research Infrastructure have been found appropriate to be supported and conditional support decisions have been delivered to the relevant University Institutions and the Ministry of Treasury and Finance on 12 November 2018.

The Ministry of Treasury and Finance launched a call on 11.01.2019 regarding these funds. The Ministry of Treasury and Finance has completed the assessment processes of applications and announced it's decision on 09.11.2019 regarding the funds which have been found appropriate to initiate the protocol processes. Within this scope, the list of 5 funds of which's protocol processes are to be launched by the Ministry of Treasury and Finance and 12 university institutions to participate in these funds is presented to the public below.
