The Call is open between 10th October 2019 and 13th December 2019

1. Preamble

In the framework of the Agreement on Cooperation in Science and Technology between The Scientific and Technological Research Council of Turkey (TÜBİTAK) and National Academy of Sciences of Belarus (NASB) which also supported by the currently signed Road Map Agreement 2019-2022 between the above mentioned organizations, universities and public Research Centers are invited to submit joint proposals for Research and Development (R&D) projects.

2. Objectives of the Call

The aim of the call is to allow partners to collaborate internationally, and gain access to new research environments, facilities, knowledge, and expertise, in order to enhance the quality of their research and enable them to translate research and innovation into economic and societal benefit.

3. Main Thematic Areas:

This call is for applications in below mentioned scientific and technological areas:

- Optics for Earth Observation from Space
- Batteries for Electric Vehicles and Other Vehicles
- Unmanned Aerial Vehicle
- Composite Organo-mineral Materials and Mineral Processing
- New Materials
- Use of Information Technologies

4. Financial Issues

As a rule, **Turkish partners** that are eligible for funding can receive **up to 720.000 Turkish Liras** (excl. overhead and Project Incentive Premium (PIP) approximately) per project.

Also, Belarus partners that are eligible for funding can receive up to 120.000 USD Dollars per project.

TÜBİTAK-funded costs of each grant will be issued and managed by TÜBİTAK in accordance with with the rules of TÜBİTAK 1071 Programme. Similarly, NASB Belarus- funded costs of each grant will be issued and managed by NASB Belarus according to its funding guidelines and procedures.

The costs of exchange of experts, scientists and other specialists will be covered on the following basis:

- The sending Party will meet all related costs connected with travel, lodging and allowances according to their own regulations.
- The sending Party shall be responsible for the emergency health insurance of its scientists.

5. Duration of the Projects and Expenses

The duration of the projects should not exceed two years and the total duration of international visits should not exceed two months (60 days) per year for the each supported joint research project.

The projects will be monitored through progress reports and the final report by both TÜBİTAK and NASB Belarus for its content and progress.

The costs of exchange of experts, scientists and other specialists, resulting from this Protocol, unless mutually agreed otherwise in writing, will be covered on the following basis:

The sending Party will meet all related costs connected with travel, lodging and allowances according to their own regulations and allowances. The sending Party shall be responsible for the emergency health insurance of its scientists, including medical care.

6. Proposal Submission

The Joint Call will be open for applications between 10th October 2019 and 20th December 2019 through online application systems of TÜBİTAK and NASB Belarus. Turkish partners will make their joint online application via TUBITAK's UIDB-PBS online system, uidb-pbs.tubitak.gov.tr.

- The partners should come to an agreement with each other using their own means of communication and jointly develop and complete their project proposal before submitting it to TÜBİTAK and NASB Belarus. TÜBİTAK and NASB Belarus do not match the collaborating partners.
- The proposals should be prepared in **English**.
- Project proposals must provide detailed information on the objectives and justification of the planned joint research work, the methodology to be followed, the composition of each research team and the intended time schedule.
- Turkish partners will make their joint online application via TUBITAK's online system reachable from uidb-pbs.tubitak.gov.tr.
- Turkish partners will use E-Signature for their applications. Detailed information can be achieved via <u>http://www.tubitak.gov.tr/sites/default/files/281/ardeb e-</u> <u>imza yardim dokumani.pdf.</u> Because of that situation there is no need to send any hard copy to TÜBİTAK.

Belarus partners should follow the relevant rules and requirements of NASB Belarus.

7.2. Evaluation Method

- The proposals that are deemed eligible will be evaluated by TÜBİTAK and NASB Belarus in line with their own rules and regulations.
- Following the scientific evaluation, TÜBİTAK and NASB Belarus will inform each other a result list that will be include the information about approved and rejected project proposals.
- Only the project proposals, which will be approved by TÜBİTAK and NASB Belarus will be supported.
