- If scientists employed at T.C. institutions/organizations, participate in 1001 projects proposed from KKTC institutions/organizations as a researcher and/or consultant, those projects are excluded from the quota.

- In the scope of 1002-A and 1002-B funding programs, **(1)** one can participate as a principal investigator (PI) in 2 projects, **or (2)** as a PI in 1 project and researcher in 2 projects, **or (3)** as a researcher in 4 projects concurrently.
